

ABSTRACT

Village Government plays an important role as the spearhead of the success of various programs pembangunan in the area. To achieve this required a reliable Village Government and responsive to serve and understand the needs of the community related to the implementation of development programs in the village.

The village head and the whole of the village is required to read the people's aspirations. Among the villages that have hefty duty heavy is the head of the hamlet. As a constituent territory of the village, hamlet chief has task management and implementation of governance, and social development, peace and order in their respective villages. Glance this task seems similar to the task of the whole village chief care of all interests and services needed by the community. Therefore, the community is hoping that a chief who led in the hamlet Hamlet is a competent, able and willing to work hard for the benefit of the village lead.

The desire to have a figure that is expected to Head Hamlet, it will usually be actualized during the selection process Head Hamlet. The process is not much different from the implementation of the Village Head Election was deemed capable of delivering a Village Head respected, capable and willing to serve exemplary for the benefit hamlet.

Along with Lamongan Regional Regulation No. 12 of 2006 which regulates procedures for filling The Village (including the Village Head) by using a system of selection through written test then there is dynamic in its application. Therefore the research entitled "Dinamika Proses Pengisian Kepala Dusun Pasca Berlakunya Perda Nomor 12 Tahun 2006 (Studi Kasus Pengisian Kepala Dusun Dagangan Desa Babatagung Kecamatan Deket Kabupaten Lamongan)" aims to explore and describe the process of filling the Village Head.

The method used in this research is descriptive qualitative method explorative approach. Data were analyzed qualitatively, while data collection is done through interviews, observation and documentation.

The findings showed the hamlet Merchandise Babatagung Village can not accept such changes for filling Village Head who normally use the choice turned out to be through a written exam as a result of the birth of Regional Regulation No. 12 of 2006. Internally the hamlet Merchandise then did the election of Hamlet in Hamlet Merchandise and winner of Pilkasun were requested to register for the written exam. The factors that cause the dynamics in the process of filling this hamlet are: *first*, lack of socialization factors, where the time it takes between the release of the legislation with the implementation is too short and *second*, custom / old way which has become the benchmark in the implementation of charging head to accommodate the aspirations of the village community through choice; *third*, filling the void in the hamlet hamlet Merchandise Babatagung village is charging the Village Head "first" at the district level, post-discharge Lamongan Regional Regulation No. 12 of 2006, so the "start something new" feels a bit alien to society.

It is therefore recommended that: first, the Local Government failure by immediately disseminating products that have been made to the law to the village to

be known by the public, especially related products in direct contact with the Law of public interest, and second, a good control by the relevant local government with the laws and regulations that must be enforced, to prevent different perception in the community related to the emergence of a legal product.
