Authors should elaborate references mentioned in the tables to make table more concise or reduce numbers of references if needed. Formatting the references list should be according to submission Guidelines. Please check whether the journal title should be abbreviated or not. English needs to be improved. Some grammatical errors should be checked and revised.

Please provide a harmonization in using "Microparticles" or "microspheres". Report

Alginates being the natural polymers and approved by US FDA has been explored by many research reports worldwide especially for delivery of drugs and there are many reports which have shown the successful applications of alginates for this purpose. The authors have provided the thorough review of application of alginates for drug delivery, they covered in details the chemistry of the alginates and then various methods used for modification of alginate molecules so that these can provide either nano particles drug

delivery or for sustained release of the drugs. The authors also discussed in details the kinetics of the alginate drug delivery systems and applications using various routes of administration including the ophthalmic drug delivery systems based on alginates. Subsequently they have discussed the toxicity of the alginates drug delivery systems and showed the advantages of using these natural modified polymers which have shown significant flexibility.

Report The submitted manuscript presents a comprehensive review on the use of Alginate for drug delivery applications. The authors have focused on the various routes of alginate-based drug or protein delivery, the effectivity of alginate in stem cells and cell encapsulation and
