COMMENTS FOR THE AUTHOR:

Reviewer #1: The authors' answer to the second comment is ambiguous, and this may be due to a lack of clarity in the initial comment. Therefore, I reformulate it in a more explicit way. The authors should control, in one way or another, for subsectors and administrative divisions across Indonesia. This would be justified as access to credit is likely to vary across districts (or provinces), and sectors. For instance, conditions of access to credit may not be the same in Jakarta/west Java compared to the rest of Java/Indonesia. Same remark across sectors, due to information asymmetry and as in the distribution of credit, bankers have a bias in favor of large and state-owned firms.

In order to do so, you may include district/kabupaten (or province) dummies and 2-digit subsectors dummies in your current model. An alternative would be to use conditional DID (Heckman et al. 1997) or nearest neighbor matching estimator (Abadie & Imbens, 2006).

Native-Speaker proofreading is recommended to eliminate the final remaining spelling and grammar mistakes.
