

penurunan pada risiko sedang sebesar 100%, dan risiko tinggi sebesar 71% sehingga risiko yang masih tersisa yaitu 33% risiko sedang dan 13% risiko tinggi.

7.2 Saran

Saran untuk unit pengemasan dalam penelitian manajemen risiko keselamatan kerja di unit pengemasan PT. X yaitu:

1. Mendokumentasikan semua temuan dari hasil inspeksi oleh inspektor yaitu mandor, untuk mengetahui informasi bahaya dan risiko yang telah ditemukan dan dikendalikan, sehingga bahaya dan risiko tersebut dapat dilakukan peninjauan ulang bahaya.
2. Masukan yang dapat diberikan pada unit pengemasan untuk mengurangi risiko dari bahaya yang ada yaitu dengan upaya pengendalian secara APD dapat dilakukan dengan memberikan APD yang sesuai standar seperti helm dan sepatu *safety*. Penerapan rekayasa teknik dapat dilakukan apabila risiko tersebut termasuk dalam kategori risiko tinggi.
