

### Comments:

Thank you for the opportunity to read and review your revised paper. I appreciate that you were responsive to my concerns and took steps to address most of the identified issues. I think that the paper is improved from the original version. I also have a number of concerns that I think should be addressed, listed below in the approximate order of importance (most importantly, the paper needs to be proof-read).

#### Minor issues

- P. 3, 2nd paragraph: "Main Result" and "Robustness Test" should be in plural form.
- P. 4, the last sentence in the 2nd paragraph is split accross the two paragraph.
- P. 6, in 5th paragraph, the sentence "Furthermore, military personnel lack technical skills" is split as well.
- P. 6, last sentence: "tend" should be instead of "tends".
- P. 7, Table 1: "Final observation" should be replaced with "Final number of observations".
- Pp. 9-10, Table 2: "Descriptive Statistic" should be replaced with "Descriptive Statistics" (2 instances).
- P. 11, Table 3: some columns should be widened to ensure that negation sign is in front of the relevant number rather than above it.
- P. 12, last paragraph: it should be "adjusted R2" not "R2".
- P. 13, first paragraph: "heckman" should be replaced with "Heckman".
- Pp. 15-16: The authors did not respond fully to Major comment #6 from the previous round. What are the correlations between MCON and MDISTANCE as well as between MCON and PROBCONNECT?
- P. 17, first sentence: the significance levels of MCON and MDISTANCE are not described correctly.

- P. 17: It seems that the authors did not fully respond to Major comment #7 from the previous round. Lai, Li, and Yang (2020) "consider firms that experience at least one instance of CEO turnover in the sample period." However, the authors include "firms that recruited ex-military for one year during the study period". Instead the authors should include firms that recruited ex-military for at least one year during the study period but less than for the entire study period (i.e., there should be at least 1 year when a firm does not employ ex-military personnel).
- P. 20, second paragraph: not clear what the authors mean by "Most of their value is interrelated".
- p. 32: Given that a regression include fixed effects, one does not need to report the coefficient estimate for intercept (\_cons).
