SYNOPSIS

Finally, Erdemovic plans to reveal his crime was success. He met with the reporter and told everything about his crime against humanity. Yet, he was arrested after the transcription of his admission confiscated when the reporter at the airport. Erdemovic is in a jail to wait for his court session.
