Thank you for your reply. Before we can proceed with your submission, we have a few questions regarding the ethics process that must be resolved. Please could you clarify the following:

- Per our policies, we would expect that ethics approval be obtained before the study. In your manuscript you have said that you obtained ethics approval in February 2021, but that the study was conducted in 2020. **Please could you clarify why you did not obtain ethics approval until after the study was conducted?**
- **Was the oral hygiene assessment performed solely for the purpose of this study, or was this performed as part of a routine check up and the results included in this study?**
- I am unclear from your consent statement if consent for the oral exam was obtained from the parents or the children. **Please could you confirm if written informed consent was received from all parents?** If not, please clarify if the children provided this or if it was a mix or some parents and some children.

This is my clarification of these questions.

1. The ethical submission for this research has been submitted since the end of December in 2019. The ethical requirements were issued in early February 2020 and research began in February 2020. When the research just started, in March-April Covid-19 hit Indonesia very quickly so the research had to be stopped because of government regulations. After several months of cessation, the Indonesian government began to allow the research to be continued with the requirement that it be carried out in a negative pressure room in accordance with WHO recommendations. So, we re-submit ethics according to these requirements. Ethic is out in February 2021. Some of the respondents were conducted before Covid hit Indonesia and partly after Covid was controlled and the government allowed it to continue. Therefore, we include the last ethic.

Please suggest whether we use the first or the last or both?

2. The oral hygiene assessment was carried out for the purpose of this study. There is no routine dental check up for children with special needs yet, and, therefore, their dental treatment needs are mostly unmet.

3. All of the written informed consent was obtained from the parents because the children could not give their own consent considering the child's age and condition.

Thank you for your message, I hope you're well. I'd like to thank you for your recent reviewer suggestions – they are currently being checked against our reviewer suitability criteria to confirm whether or not they are suitable to review for your article.
