The authors are requested to revise this manuscript to make the content and the diagnosis clear, to provide more details and supporting References in the Background section, to write the main Case Report clearly and chronologically, to clearly describe what may be learned from this case, and to reduce the number of Figure images and provide a clear description of what the images show.

1. This case appears to be of a 43-year-old woman with a history of multiple cesarean sections with who required laparoscopy for abdominal adhesions, and removal of an intrauterine device - IUD - from a uterine cesarean delivery scar. Throughout the manuscript, please be clear and consistent with this diagnosis.

2. Please read and follow the Instructions for Authors for the American Journal of Case Reports and format the manuscript and the References correctly.

3. Publications are searched and cited based on the clarity and content of the Title, and the Abstract, and are searched on PubMed using MeSH Keywords.

4. Therefore, a clear and descriptive Title is required. ..... Laparoscopy for Abdominal Adhesions and Removal of an Intrauterine Device from a Uterine Cesarean Delivery Scar in a 43-Year-Old Woman with Three Previous Cesarean Sections.

5. Please write the content of the Abstract as clearly as possible. The Background subsection of the Abstract should clearly state the aim of the report.... This report is of a 43-year-old woman with a history of three previous cesarean sections who required laparoscopy for abdominal adhesions, and removal of an IUD from a uterine cesarean delivery scar.
 6. Please use MeSH Keywords from PubMed...... intrauterine device, IUD, cesarean section, adhesions, case report.
