COMMENTS for Authors:

#### => Reviewer # 1

The Authors describe the synthesis of a small library of styrylchromones and study their anticancer activity both in vivo and in silico. It should be noted that some compounds are already known and have been studied precisely for their antitumor activity.

#### There are tipographical errors:

Page 1, line 1: not "2-styrylchromone" but "Styrylchromone"

Page 2, line 20: not "0.33 gr" but "0.33 g"

Page 3, line 3: not "stiring" but "stirring"

Page 3, line 18: not "370" but "37°"

Page 5, line 3: not ".Another" but ". Another"

Page 7, line 20: not "1,0 Hz); but "1,0 Hz, 1H);

Page 12, line 2: not "2-styrylchromone derivatives" but "2-Styrylchromone derivatives"

Table 2: not "Doksorubisin" but "Doxorubicin"

#### Major issues:

- There is no description of how the two compounds (4-methylcoumarine and 2-methylchromanone) are separated. Further, the melting point of 2-methylchromanone is missing.
- In the formulas, the order of the elements is C, H, halogen (Cl or Br) and O: for example, compound 4c is C17H11BrO2 and not C17H11O2Br.
- -There are several errors in the H NMR data:

Compound 4a: one proton is missing

Compound 4e: the signals relating to the 2 OCH3 groups are missing

Compound 4g: the signals relating to the 3 OCH3 groups are missing

The compounds 4a-c and 4g are already known. It is necessary to report this information.

- In addition, the compounds have already been studied precisely for their antitumor activity. In this regard it is necessary to mention the two references:

Lin C, Lu P-J, Yang C-N, Hulme C, Shaw A.Y. Structure-activity relationship study of growth inhibitory 2-styrylchromones against carcinoma cells. Med. Chem. Res., 2013, 22(5), 2385-2394

Momoi K, Sugita Y, Ishihara M, et al. Cytotoxic activity of styrylchromones against human tumor cell lines. In vivo, 2005, 19(1), 157-163.

- The value of percent inhibitions (Table 2) are obtained with a single experiment (poor scientific significance) or are the average value of several experiments. In the latter case, the standard deviation must be reported. In the first case, it is necessary to specify that the results are obtained with a single assay.

#### => Reviewer # 2

The work is average but may be improved by the inclusion of the following suggestions.

- 1. English should be improved throughout the manuscript.
- 2. Quantitative information should be provided in the abstract.
- 3. The concussion should be concise and to the points indicating the application of the work.
- 4. The novelty of the work should be established.
