=> Reviewer # 1

Authors here demonstrate the potential of Petiveria alliacea leave extract on insulin receptor sensitivity through suppression of proinflammatory cytokines namely TNF-α and IL-6 in diabetic rats.

- The study is interesting but is missing essential experiments to support the conclusion claimed by the authors. The manuscript may be accepted after major revision.
- While they have tried to explain the possible mechanism of P. alliacea leaves extracts through reducing IL-6 and TNF-α levels via AMPK activation, presently there is no data to prove the same (the critical bridging link for the main goal).
- The authors have parallelly shown 3 interpretations namely P. alliacea leaves extracts can increase insulin sensitivity, decrease IL-6 and TNF-α levels, however the mechanistic explanation for these 3 results and an experimental validation of how these parameters do contribute towards alleviating inflammation in the streptozotocininduced diabetic rat model is unexplained.
- Moreover, the other inflammatory mediators such as interleukin-8, intracellular adhesion molecule 1, vascular-cell adhesion molecule 1, and monocyte chemoattractant protein-1 are not explored at all.
- There are numerous typos persisting throughout the manuscript which needs attention.


