Table II age distribution does not tally with the abstract Line 12-13 - age group of 41-60 years Line 16-17 – not to include normal hearing as a type of hearing loss, to rephrase the sentence Line 18-19- Location of hearing loss was unilateral in 23.58% of patients, and bilateral in 26.83% of patients.

There is no mention of the vestibular assessment performed for all the patients and if these examinations were standardised

I suggest- 1) to include the data on diagnoses of the cases in the 'óther peripheral vertigo' group and the 'central vertigo'

- 2) to include any imaging or vestibular investigation performed for the patients
- 3) to include explanation if the hearing loss are associated with the vertigo diagnosis or separate eg presbycusis
- 4) to add value to the article, please describe any outline of management in patients who presented with vertigo the clinic
 - 5) were patients with peripheral vertigo problem referred to ENT for co-management


