COMMENTS FOR THE AUTHOR:

Reviewer #1: This is an interesting and important study on the lives of the Indonesian illegal migrant workers. The authors have done a good job of describing the dire lives conditions of the Indonesian illegal workers in an authentic way. However, there are some issues that may need attention to improve this manuscript.

1. The Abstract should point out the methods and the main findings of this study.
2. In the Introduction section, it will be better if the authors explain a little bit longer the purpose of this study and how it can be achieved.
3. Minor reorganization of the Literature Review section is needed to make it clear and follow in a logical sequence. The literature review also seems to make many repetitions on the conditions of the Indonesian illegal migrant workers (mistreated, exploitation, abuse, human trafficking).
4. The Method section should be added with the procedure on how to recruit the informants.
5. All tables need to be referred to in the text.
