Please kindly check the grammar and punctuation used in the manuscript, for example last sentence in Preparing cuttlefish xeno bonegraft part of methods (there is no closing parenthesis).

HA: what is HA? hydroxyapatite? First abbreviation should be mentioned, later it can be abbreviated (in discussion)

XRD: what is XRD?

Citotoxicity test using MTT assay:

CBP: what is CBP?

Results:

1. First explain how was the viability, and then refer to the table (see comment on text)
