Reviewers' comments:

This is an unusual but very impressive and illustrative case of bilateral ergot-induced ampultation of the feet in a child.

Overall, it is well written and clear. However, in order to be publishable, there are a few issues that should be changed:

- There are far too many highlight bullet points. Please limit to the 3-4 most important ones
- Since this is not "autoamputation" but rather "Ergot-poison induced amputation", the title should be changed accordingly.
- In the introduction, the first sentence is trivial. The point here is that bilateral foot necrosis is extremely debilitating, so I would suggest "Bilateral gangrene of both legs in a child is a severely debilitating condition."
- Also, the presentation should include whether there were any co-morbidities. If not, please write "An otherwise healthy five-year-old girl fell from a bicycle..."
- Do the authors know whether there were any fractures after the fall? That would be important to understand if the vascularization was compromized by the fracture rather than by the herbs.
- What does "discharged by force" mean (in the case presentation). I hope that does not mean that they were kicked out of the hospital. Perhaps can be reworded.
- Overall, the text is too long. Introduction, case presentation and discussion should be shortened by 1/3.
- The laboratory values do not have to be presented in whole. Please delete the tables and state pertinent values in the text.
