1 - PG 8 Line 43 - add country name.

2 - Has the WHO Quality-of-Life BREF (WHOQOL-BREF) been validated for the country's population?

3 - Were there no exclusion criteria for respondents?

4 - Was the outlier treated?

5 - Pg 13 Line: 52 - 59 - Quality of Life is not the same construct as well-being in life, so it should not be used as a synonym.

6 - Pg 13 line 56 to 14 line 3 -17 - The authors argue "In the pre-pandemic period, fishermen could easily get satisfaction and well-being in life, both physically, psychologically, socially, and environmentally because they have been exposed to globalization, sophisticated technology advancements and modernization. This might influence how they work and face challenges of daily living including their ability to cope with nature when weather conditions change, the ability to predict the weather". However, in Pg 14 Line 13 - 40, the authors argue that the respondents "This maybe because, while fishermen may have aspirations for education, they did not have the mindset that education is an important aspect in improving the quality of life. In addition, in the case of the Terengganu fishermen, their low quality of life was also influenced by the high level of competitiveness and big numbers of fishermen in the coastal areas working within a limited fishing area which affected their daily income". My suggestion is that the authors review the argument.

7 - Pg 18, Lines 43-59: The authors highlight "Changes in the lifestyle of fishermen were the most likely reason for the difference in the quality of life of fishermen between the pre-pandemic era and during the pandemic". Why the most likely? Which dimension was most important for the WHO Quality-of-Life BREF (WHOQOL-BREF) total score?

This is an interesting research to see the change of QoL among fisherman in Kenjeran coastal area, Surabaya City. The results presented the decreased of QoL before and during pandemic COVID-19 but there is lack of information the time and how to collect the QoL before pandemic. The methods only stated data collected in the beginning of pandemic and current, but there is no information about when the "current"

author means? Beginning of pandemic is not same with before pandemic, it's need more explanation about data before pandemic. The result of comparison before and during pandemic it would be better show in table not in figure. The discussion should explained more why the fisherman felt decreased of their QoL and need more citation that related with QoL of other fisherman. Conclusion should conclude based on the results which part of different between before and during pandemic. There is need major revision in methods, results, discussion, and conclusion.

WHO has published WHOQOL-BREF and it has been translated into 40 different languages, including Bahasa Indonesia and the validation and reliability have been validated by WHO itself.

Secondly, regarding the information about "before" and "during" the pandemic, fishermen, as the subject of this study, are filled the two same questionnaires. One for their perception about their quality of life before the pandemic occurs, and another is about their perception about their quality of life during the pandemic. Since this study is taken during the pandemic, fishermen are asked using two same questionnaires but different perspectives (before and during the pandemic).

There are no exclusion criteria for the respondents and the outliers are not treated.
