Reviewer Comments:

Reviewer #1: The objective of the paper is to compare the Patient Safety Reporting System in three Asian countries (Malaysia, Indonesia and Taiwan).

The major issue with the paper is the methodology. Effort need to be taken to improve the methodology writting.

Comments:

Methodology is weak and can be further improved.

#1 Reason for selecting the three countries is weak.

e.g. How would climate of the countries influence patient safety reporting as mentioned in introduction?

#2 How was the official website obtained? Explanation of search method can be further elaborated.

#3 How did researchers obtain the guidelines, regulatory documents and ect ... from the countries reviewed. Can further explain regarding this matter in the paper.

Also no details on how permission were obtained to review and report these documents mentioned in the

methodology.

#3 The component 'evaluation' added need to be described in detail.

Extraction of components from the WHO for successful patient safety reporting system can be described in methodology. A table to represent these component with definition would be useful for readers.

Reviewer #2:

Relevance and novelty of the study

The exercise is somehow informative, however it doesn't add to the global conversation from an academic point of view.

Methodology

The method section is too short, no formal review procedure was used. It feels like a narrative comparison without methodological or theoretical backbone.

Results

The text is narrative, difficult to compare the systems side by side

Some form of visual overview or table could be useful to compare te systems under study

Discussion

Weak, local impact us described, the added value from a global perspective is missing.

Reviewer #3: This article compared different incident reporting systems in Taiwan, Malaysia, and Indonesia. The topic is interesting and important. There are several comments and suggestions:

- (1) It is confusing that authors compared only national incident reporting systems, or both national and local systems. As there are different levels of incident reporting systems, e.g., national level system and hospital-specific systems, it is necessary to clarify that hospital level in the paper is hospital's own system or how hospitals use the national system. From citations, it seems that hospital level here sometimes refers to hospital's own system. However, different hospitals have different systems, different analysis methods, different learning methods, it is not appropriate to have the same statements to all the hospital-specific systems in one country.
- (2) As objectives of the paper is to learn from other countries, at first, there should be a definition of what is a good practice. For instance, more incident reports stand for better practice? Is it enough?
- (3) Although this is a comparison study, descriptions of three countries' reporting systems are totally separately in

Results section. It is difficult for readers to get the similarities and differences. Authors may make several categories for "types of systems", "process", "classifications",..."evaluation", respectively. Then compare the systems using the same categories, e.g., whether the category is included and how.

- (4) Authors need to clarify that the contents included in the paper are guidelines, practice (conducting), or researchers' proposals, etc. For instance, contents of reference 13 (for Taiwan) is about proposals, it may be not hospital level for all the hospitals in Taiwan. Thus, when make comparisons, sometimes it is unfair.
- (5) About discussion, most of the descriptions are comparison results, these are not discussions of results. Authors can discuss the results from the viewpoints of such as culture, establish time as mentioned in the reasons why Malaysia and Taiwan were chosen. And discussions can also be about, e.g., considering culture and some other reasons, something can be learned and some are not appropriate.
