"Two years after implant removal, pain increased", clarify

"Radiologically, we found OA ankle stage 3 with a TAS angle 74o (normal 88o-93o) indicating Varus-deformity" perhaps revised to 'upon presentation to our clinic, the patient was diagnosed with stage 3 osteoarthritis and a Varus deformity measuring 74o of TAS.'

"The patient had history of diabetes mellitus and denied alcohol consumption" had, means no longer diabetes. Perhaps, revise with something like 'patient presents with accompanying diabetes mellitus (controlled or not-controlled) but denies alcoholism'

"Conducting Talar Tilt Test, examiner stabilized distal leg with one hand while the other hand held the heel in neutral position. The heel was inverted against the tibia. The pain appeared in the area thus indicating positive test" simplify to 'talar tilt test was positive'

"Diagnosis was concluded from thorough anamnesis, physical-examination of ankle ROM, and radiologic imaging" please revise to a rational and concise sentence.

"The patient did not have any preoperative health issues" on the contrary he has diabetes mellitus!

'we used a clover-leaf® plate and 6 screws for fixation'

"Four-weeks postoperative condition shown in Fig. 5" please complete sentence with a verb

"End results was satisfactory. Pain progressively decreased and TAS angle was 89°. Postoperative functional evaluation by American Academy of Orthopaedic Surgeon-Foot and Ankle Measurement questionnaires showed significant improvement, while preoperative result was 89, the postoperative result was 38(pre 89°, post 38°) (Fig. 6)" need revision perhaps as follows.
