Comments to the Author

I'm trying to understand the limitations of the secondary data used, but of course the applicability of the results to the population is much more important. For this reason, it is important to prioritize the interests of utilizing the results of research publications.

Thus the conclusions are quite limited to the proposed targets that must be explored in more depth, no need to involve proposals on policies (although this is actually only a suggestion, but it would be much better if it was not included). This is also in accordance with the research objective that this research will only analyze specific targets for expanding the NHI's membership in Indonesia based on the background.

If the author's want to add suggestions, then it should be aimed at evaluating the current strategy, if it is appropriate or even better, then there is no need for a proposed policy change.

Comments to the Author

Thank you for an interesting article. Here are some comments:

- 1. In the discussion section, we can see that most of the results agree with previous findings. Therefore, it would be more interesting to explore the different characteristics in terms of setting priorities (i.e.: which characteristics you think will be the most strategic to target) in the context of Indonesia's NHI system, especially since the result is supposed to guide the government to design an effective strategy to boost NHI membership.
- 2. The article is easy to read and understand. However, some arguments feel hanging (e.g.: line 251-252, unclear how this is contrary to the finding). The wordings can be awkward in some places, may be beneficial to use a language editing service.
