Please include the location and period (years) in which the data was collected. Use only numbers with two decimal places. What exactly does it mean to "experience delivery care"? The phrase "The richest were 5.602 times." is not clear, rewrite it. Include the 95%CI in the results.

The introduction is long, can be reduced, keeping the focus on childbirth in adolescents. Other aspects can be moved to discussion (paragraph of line 42)

The meaning of "healthcare childbirth" is unclear. Do the authors refer to childbirth assistance?

Design and methods: no comments

Results:

Many results in Table 3 are repeated in the text. Adjustments are requested to the section "**Multivariate regression analysis**"

Table: 3: do not use notes with * as the p-values are written in the table. Do not use "sig." to refer to p-value.

Thanks for your email.

The authors have improved the manuscripts based on reviewer feedback. Manuscripts with marked improvements are attached in.

Based on reviewers' suggestions to choose the subject between "adolescent" (10-19 yo.) and "youth" (15-24 yo.), The authors agreed to change the subject to "young people" (10-24 yo.) According to WHO criteria.

Meanwhile, several suggestions for improvement from other reviewers were answered point by point as follows:

Please include the location and period (years) in which the data was collected. Use only numbers with two decimal places. What exactly does it mean to "experience delivery care"? The phrase "The richest were 5.602 times." is not clear, rewrite it. Include the 95%CI in the results.

+ Location and period (years) have been added to the abstract. Including 95%CI in the results.

The introduction is long, can be reduced, keeping the focus on childbirth in adolescents. other aspects can be moved to the discussion (paragraph of line 42)

+ The paragraph in the introduction has been reduced, moved to the discussion

The meaning of "healthcare childbirth" is unclear. Do the authors refer to childbirth assistance?

+ It has been fixed according to suggestions. "Healthcare childbirth referred to the respondents' acknowledgment of delivery locations in the past five years. Healthcare childbirth if childbirth is carried out at healthcare centers, clinics or maternity hospitals, practices of health workers, and general hospitals. Conversely, it is categorized as non-healthcare childbirth if it does childbirth outside that location."

Many results in Table 3 are repeated in the text. Adjustments are requested to the section "*Multivariate regression analysis*"

The government also needs to provide a mobile unit for maternal health services in peripheral areas with poor access."
