For better understanding to international readers, perhaps authors can consider translating the Indonesian currency to USD denominator.

For validity, the authors could explain the protocol/steps in conducting the interview and FGD.

#### Additional Questions:

   Yes. There are relatively few studies concerning pesantren's business community network model in Indonesia.
