"Camouflage Treatment of Skeletal Class III Using Orthodontic Conventional Technique"

Class III malocclusion can be defined as a skeletal facial deformity which characterized by a forward mandibular position with respect to the cranial base and or the maxilla. This case report describes the camouflage treatment of skeletal class III using orthodontic conventional technique. The case is that of a 15-years old male patient with skeletal Class III malocclusion that treated with non-extraction orthodontic camouflage treatment by using orthodontic conventional technique. Fixed appliance, Straight Wire Appliance (SWA) technique was used with non-extraction treatment plan. During treatment also accompanied with intermaxillary Class III elastics. Total active treatment time was 23 months. There were significant improvement of his occlusion, smile esthetics, and soft tissue profile. The orthodontic camouflage can be considered as an effective therapy for correcting of milder skeletal Class III malocclusion.

- Define the gap in knowledge (problem statement) that you want to address in this paper.

- Do not abbreviate (RSGM FKG UNAIR), use the full term.
- Heading must be clearly defined, avoid the sub heading if possible.
 - Suggestion: Introduction, case presentation (including: diagnosis, etiology), case management (including: treatment objectives, plan, progress, result), discussion, conclusion.
- Mention the good points of the treatment phase instead of describing everything in detail.

F. Results

 For case report, I recommend to put result in the "case management" section.

G. Discussion

Best part of this case report.

H. Conclusion

- Avoid using long sentence.
- Provide the key conclusion, answering the aim of this case report. A
 new knowledge that readers might gain from this paper.

I. References

Should be updated since 21 of 28 references were >10 years.

J. Tables/Graphs

If possible, give explanation following title of table 1. What readers need to pay attention to the cephalometric measurement.

K. Figures, Illustrations, Photos




