> Reviewer 2: GENERAL COMMENTS

> In this manuscript, the authors examined Mets-IR and HOMA-AD in obese adolescents. However, similar reports had already been published elsewhere by the other group (Bello-Chavolla OY Eur J Endocrinol 2018, Viela BS PLoS One 2016, Kurtoglu S J Clin Res Ped Endocrinol 2010). Therefore, novelty of this paper is limited. The authors should focus on and clearly describe what is novel based on the previous observations. Furthermore, important information had not shown in Material and Methods and Figures. Thus, the study is too preliminary to be published in its present form.

> SPECIFIC COMMENTS

> 1. The authors should describe diagnostic criteria of Mets, reference range of waist circumferences and each lab data. When blood sample obtained? How about assay of lab data? The authors did not describe whether the data was shown in SD or SE.

> 2. AUC, sensitivity and specificity data of ROC analysis were relatively low compare to previous studies. The authors should discuss about this point.

> 3. On page 5, the unit of insulin was not correct.

> 4. The author should indicate which figures or tables the data presented results section came from.

> 5. On table 1, please indicate the number of patients separately for gender.

> 6. On table 2, the authors should show the scatter plots.

> 7. Figures were most important data of this manuscript. However, there were limited information and assessment concerning about the figures. Cut-off points should show in the figures. The figure legend was not enough to understanding. The author should discuss those key data in more depth.

> Reviewer 3: 1. The title should be modified. Example, Indonesian obese adolescents, METS-IR and

HOMA-AD are useful indicators for .

> 2. The author defined MetS according to definition of IDF 200. How the IDF 2000 define MetS on young adult?

> 3. Subject's characteristics should be shown in mean and standard deviation.

> 4. In table 2, statistical significant correlation was observed some variables but these values were low.

> 5. In table 4 and 5, characteristics between MetD and Non MetS, or IR and Non-IR were very similar, I think. Therefore, conclusion that METS-IR and HOMA-AD is good maker for MetS and IR, respectively is not supported.
