CHAPTER I INTRODUCTION

I.1. Background of the Study

For there are good and bad conditions happened in this worldwide, she is then captured by Joads' struggle in order to get better life on the land which is crushed by drought There are about and depression. five thousand families, one of them is Joads, not just hungry but actually starving. They are described insecurity, low income, homeless, inadequate standards of living, maters of education and impoverishment in cultural opportunities, and a lack of spiritual satisfaction. By seeing the condition like that the writer wants to know. how they live in their damaged or deteriorated place, how they stubbornly struggle to remain in that place. What makes them leaving Oklahoma is that they want to find a better life in California. That is why she is interested writing literary appreciation on one of John Steinbeck's popular stories, The Grapes of Wrath.

This novel describes how difficult life the migrants experience. The standard of their living is very

low. They are still wishing for work, to have food for their children, and a shelter for their home, not a tent or cartons for their houses. They are very suffering. They don't know how long they will be able to keep their family alive at that rate. They are very poor and have not enough clothing to wear. Education is unknown for them because the only thing they must think is how to survive in that land.

The novel demonstrates how labor organizations the desperation of the workers and how grow from take the profit from machinery that will capitalism laborer. The oppress and even destroy the lower usually bears a disproportionately large class share of the costs of social change. When there are many people without jobs, competition among them them to accept lower wages for if they refuse to work for low pay, there is someone else desperate to take their place. Low wages, in turn, mean higher profits for the owner.

Oklahoma farmers who are wiped out by the Great Depression go to California in search of jobs in fruit orchads. In spring, all of the plants begin to grow up in California. When the harvest time comes the big canneries are owned by the big landowners and then they depress the prices and force whole sale of crops eventhough people are starving everywhere. Each day, the owners spread

rumors that large number of jobs are available; an enormous crowded gathers at the gate, and the owners announce a pitifully low rate of pay. The people looking for work can see that only a few of them will get jobs, that they are all hungry and homeless, and that even a low wage is better than no wage at all.

As the writer stated in the background of the study this novel describes Joads' struggle in order to get better life in the depression era. They are described insecurity, homeless, low income, and inadequate standard of living. This novel represents how difficult life they experience during the drought and depression, and how they struggle to survive spiritually and physically.
