CHAPTER IV CONCLUSION

Conclusion

The phenomenon that legal Documents is difficult to be understood is true. Legal language has its own characteristics in its sentences. The characteristics of the sentence of the Bank Documents become the interesting object for me to investigate.

Based on the analysis, I conclude that:

- 1. The sentences of the Bank Documents tend to be long and most of the sentences are compound -complex sentences.
- 2. The sentences of the Bank Documents are formed by partallel structures.
- 3. There are a number of complex and ambigious sentences. In this case, the ambigious sentence arise in its noun and verb phrases. Besides, a lot of prepositional and noun phrases are repeated.

The structure of the legal Documents

1. Sentence -----> Clause + Conjuction + Clause

The sentence of the Bank Documents is constructed by two clauses.

2. Sentence ——> Cjs, Clause + Cjs, Clause

The sentence of the Bank Documents is constructed by two clauses which are conjoined by two subordinating conjunctions.

3. Noun Phrase \longrightarrow Det + N + N + N + N + Cjc + N + PP

The noun phrase in the sentence of the Bank Documents is constructed by determiner, one or more nouns, and a prepositional phrase.

4. Noun Phrase ----> NP + NP + Cjc + NP + Adj cl

The noun phrase in the sentence of the Bank Documents is constructed by one or more noun phrases and an adjective clause.

5. Noun Phrase \longrightarrow NP + PP + Cjc + PP + Cjc + PP

The noun phrase in the sentence of the Bank Documents is constructed by a noun phrase and two or more prepositional phrases which are conjoined by coordinate conjunctions.

- 6. Noun Phrase ——> Det + Adj + Adj + N + PP The noun phrase in the sentence of the Bank Documents is constructed by determiner, adjectives, a noun and a prepositional phrase.
- Noun Phrase ----> NP + PP + Adj cl
 The noun phrase in the sentence of the Bank Documents is constructed by a

noun phrase, a prepositional phrase, and an adjective clause.

8. Noun Phrase \longrightarrow Det + Adj + Adj + N

The noun phrase in the sentence of the Bank Documents is constructed by determiner, one or more adjectives, and a noun.

- 10: Noun phrase ----> Det + NP + Adj cl

The noun phrase in the sentence of the Bank Documents is constructed by determiner, a noun phrase, and an adjective clauses.

11. Noun Phrase \longrightarrow Det + N + Cjc + N + Adj cl

The noun phrase in the sentence of the Bank Documents is constructed by determiner, one or more nouns, and an adjective clause.

12. Noun Phrase ----> Det + Adj + Adj + NP + PP

The noun phrase in the sentence of the Bank Documents is constructed by determiner, one or more adjectives, a noun phrase, and a prepositional phrase.

13. Verb Phrase \longrightarrow Aux + VB + NP + VP

The verb phrase in the sentence of the Bank Documents is constructed by auxiliary, a verbal, a noun phrase, and a verb phrase.

14. Verb Phrase \longrightarrow Aux + PP + VP

The verb phrase in the sentence of the Bank Documents is constructed by auxiliary, a prepositional phrase, and a verb phrase.

15. Verb Phrase \longrightarrow Aux + Adv + VB + VP + Adv cl.

The verb phrase in the sentence of the Bank Documents is constructed by auxiliary, an adverb, a verbal, a verb phrase, and an adverb clause.

- 16. Verb Phrase ----> VB + Cjc + VP + NP The verb phrase in the sentence of the Bank Documents is constructed by a verbal and a verb phrase which are conjoined by coordinate conjunction, and a noun phrase.
- 17. Verb Phrase ----> VB + VP + Adv cl + Adv cl
 The verb phrase in the sentence of the Bank Documents is constructed by a

verbal, a verb phrase, and two adverb clauses.

18. Verb Phrase \longrightarrow VP + Cjc + VP

The verb phrase in the sentence of the Bank Documents is constructed by two verb phrases.

19. Verb Phrase ——> To + VP + Cjc + To + VP + Cjc + To + VP The verb phrase in the sentence of the Bank Documents is constructed by two or more the forms of "To and verb phrases ".
