CHAPTER I

INTRODUCTION

I.1 Background of The Study

Literature is a permanent expression in words of some thought or feeling or idea about life and the world (Rees:9). In literature the author tries to present the work in which the reader can learn his experiences about life. He may present his experiences through the character in which there are a lot of problems to be faced and difficulties (Rees:19) so that we will understand ourselves and other people.

Novel is a fictitious prose narrative of considerable length in which characters and actions representative of real life are portrayed in plot of more or less complexity (Rees:106). In novel, the author has more chance to comment on characters, to create the setting, to include long explanation of his own philosophical idea and his opinion about life. The author will bring the readers to his intended purpose or message so that he will minimize misinterpretation about the message of the novel itself.

Thomas Hardy (1840-1928) is the author who is successful as both novelist and poet. He is a regional

novelist. he uses a part of his country which he knows well. Wessex. in all of his novels' setting. The main character of his novels are the victims of the cruel and impersonal fate. It means that all of his works are tragic. Hardy is also pessimist and a doubter in religious matters, so that his works cause the anger of many conservative thinkers. His great novels are *Far from The Madding Crowd* (1874), *The Return of The native* (1878), *The Mayor of Casterbridge* (1886), *Tess of The D'Urbervilles* (1891) and in this thesis, the writer will study his last novel *Jude The Obscure* (1896).

Jude The Obscure also uses Wessex as the geographical setting. He creates the name of the city in this area such as Marygreen. Christminster. and Melchester. those have principally taken place in Fawley. Oxford and Salisbury. Hardy uses the educational background, poverty, love and marriage and the custom of the society as the topic. This novel may criticize the society that gives no opportunity for ordinary man to get his dream in learning and love, this controversial idea of Hardy about living together without being married gave him bad reaction from the society at that time. Furthermore R.J Rees in his book "English Literature" said that:

The publication of Jude The Obscure, which by implication condemn both the social injustices and the

traditional idea of Christian marriage. angered many Christian. and Hardy had to face hostile criticism from many quarters, including the Bishop. One of them went so far as to demand that the book should be publication burned. How far Hardy was affected by the outcry against Jude is difficult to say: the fact is that he wrote no more novels. the years until his death in 1928 being devoted to Dynast and other poetry (126).

Jude The Obscure was about Jude the ordinary man when has a dream to get a university degree even though he lives in poverty. The idea of Christminster, the city in which there is a university influences him to study Greek, Latin, math, theology and history by himself. He feels he will fail when he finds out that Christminter is different with what he dreamed when he was child. He cannot go to the university because of his poverty. In this city he is also trapped in love with his cousin. Sue and living together with her. Unfortunately they have to face many obstacles such as losing his job, having to move from one city to another, living in poverty, reaching sick, and finally losing their children. These conditions are caused by society which is majority Christian and refuses the controversial idea. The death of their children makes Sue give up and go back to her previous

husband. Jude the tragic character, has nothing neither his academic ambition nor love. The failure of the dream influence his life, being trapped in alcohol, getting sick and finally he dies in loneliness.

The writer is interested in this novel because the character of Jude is very strong. Hardy depicts him as the smart boy. ambitious. hard worker but cannot manifest his dream in education and love, because of poverty and the social convention. Jude who is smart, ambitious, hard worker: is defeated by social injustices and convention. Furthermore, his love to Sue, his cousin, destroys himself because he does not realize that convention in society still handles him, however the controversial idea such as living together that opposes the social convention is dangerous and fatal to the person.

I.2 Statement of The Problems

On the basis of the background of the study there are problems that appear into the following questions:

- 1. What are the conditions that convince Jude to have the dream?
- 2. What are the conditions that make Jude's dream fail?
