CHAPTER I

INTRODUCTION

1.1 Background of the Study

Robert G Carlson (American literature, 1979:89) identifies literature as means to transmit the loves and hates, the hopes and fears, ambitions and frustration, the failure and the trumps, the questions, the problems, the experiences of people confronting life. Some writers have this idea in their works, Rudyard Kipling With his novel The Light That Failed, takes account on human desperation caused by the failure in finding love, George Eliot with her work on human desperation on The Mill On The Floss.

George Eliot is the pen name of Mary Ann Evans, who was born on November 22, 1819, at Arbury Farm near the English town of Shepperton, in Warwickshire. In the age of nineteen, Eliot (Notes on the Mills On the Floss, 1983:2) published her first poem in the Christian Observer. Eliot has her own feeling about

life: "ivy-like as I am by nature, I must...shoot out into isolated tree." Which makes her begin to question on her religious principles. In her 28th, she had reached comfortable balance between religion and moral. George Eliot was her man's name she got 1858 for her publication in Blackwood's Magazine.

George Eliot is considered to be the first modern novelist. She had reached the height of success in her days. Her works scored critical and popular scenes. She published Adam Bede and The Lifted Veil in 1859. The Mills on The Floss, followed by Silas Marner in 1861 and Middlemarch in 1872. Above all The Mills on The floss is considered her best work

The Mills on The Floss by George Eliot describes a life of family problem, a lost love, as the reflection of the family attitudes toward its member. It tells about Maggie, Tulliver's disagtisfaction in the environment forms the central action of the Mill on the floss. Maggie as the heroine of the novel is intelligent, romantic, sensitive, sensual and introspective. She is generous giving with others but require a large of love in return.

George Eliot had always been sensitivity to criticism and was subject to bound of depression. Her unusual of masculine psychology coexisted with her deep feminine temperament. The theme of love and sentiment are everywhere in her works. Telling of human conflicts and problems as the reflection of the surrounding, where the central character lives.

Desperation is one of the results of and problems, which from conflicts come mentality that they can not handle due to (The Compact Edition of the Oxford reasons. In English Dictionary: 1971 : 252), desperation is the action of loosing all hope, and a desperate state of mind in which on account of the hopelessness or extremely small change of success one is ready to do any violent or extravagant action regardless any risks. Maggie as a heroine in the novel The Mill On the Floss experiences this mental problem from her childhood to the rest of her life. Desperation as a dominant aspect in the novel The Mill on the Floss can be revealed in a deep research.
