CHAPTER I INTRODUCTION

I.1. Background of the Problem

Literature as a form of art which expresses and communicates thoughts, feelings, and attitudes toward life is important to human being in understanding the problem of life, even the life itself, since it can enlarge human thinking and give them precious lessons, new experiences and valuable perceptions. Therefore, it can make us more sensitive in facing the problem of life.

"Good literature adds to our understanding of life in the world around us. It embodies thoughts and feeling of matters on human importance." (Little, 1966:2)

Literature is also something from which we get moral education. It actually has moral purpose. Plato that by studying literature we are in some sense ourselves better people. The use of literature is fore same as philosophy that helps us toward better underour fellow human standing ourselves and beings (Rees, 1973:15). Based on that description, it can be seen that by studying literature human being is guided to obtain the best value of life.

There are several forms of literary works constituting the record of human life which reflects and portrays some aspects of activities and experiences that human being deal with. One of them is drama, a composition in prose or verse presenting in pantomime and dialogue, a narrative involving conflict usually designed for presentation on stage. In this thesis, the writer will analyze drama since it reflects how people life more obviously. It can be seen before our eyes in public performance by presenting its story in action, dialogue and expression making vivid impression. Therefore, an analysis of drama will be more easily received and understood by the reader.

"Drama is a peculiar literary form, in that it may be treated as a literature to be read privately, or as theathre. to be seen in public performance." (Little, 1966:112)

Oscar Wilde, whose drama will be discussed here, is a famous English dramatist. He introduced wit and freshness of dialogue. His play actually aren't great but amusing, that made his drama more attractive. His first succes is Lady Windermere's Fan. He has never done his works more ingenious and wittily than he does in this drama. Therefore, it can be concluded as his masterpiece.

The writer here is interested in Lady Windermere's Fan since it presents the idea of the story in freshness, compared to the other literary works which is more difficult to understand. It actually tells the story which is not so different with the reality we face in life but it

becomes more attractive since it is presented in comedy. It tells about a wife who suspects her husband for having scandal, but actually he hasn't. Ironically, the woman she meant in fact is her mother who saves her marriage from the ruin later.

In this thesis, the writer wants to describe the theme of this drama since she wants to know further about what the general idea or insight the entire story reveals. Besides, by knowing the theme, we will understand more easily what actually this drama is talking about.

In general, the study here is to know better about Oscar Wilde's works, especially this drama, and to increase our literary criticism to the literary works, specifically Lady Windermere's Fan.

1.5. Scope and Limitation

Dealing with the problem that will be discussed in this thesis, the writer tries to find the way in describing the theme so we will know what we must do to answer the problem. Therefore, the writer will focus the analysis

on the conflict of the characters of this drama since it can leads us to theme description.

Furthermore, the analysis of character is also needed to understand the conflicts since the conflicts happen because of clash of actions, ideas or desires in characters. Therefore, the writer will limit this study to the character and conflict analysis to get a brief description of this drama. Besides, she also discusses plot and setting to support the analysis itself.

1.6. Theoretical Background

The writer of this thesis will use the objective theory in analyzing this drama since she focuses the discussion only on the work itself, disregarding any extrinsic aspect. Another reason why the writer chooses this theory is that she has only a little bit of time to finish this thesis so that she won't talk any deeper about this drama from the point of view of its external aspects.

To support the objective theory in this thesis, the writer also uses some approaches in the analysis. She uses formalistic approach which regards that form and content in literary work are inseparable since she devides the analysis based on its form and its content. Love :

Feeling of affection that leads someone to do everything for the one whom he loves and for the sake of love itself

Sacrifice :

An action which is done willingly to protect another one from the ruining life or miserable thing.
