CHAPTER I

INTRODUCTION

I.1 Background of the Study

Literature is closely related to life because it is the work of human creature which represents some aspects of life, such as human problems, experiences, and conducts. The study deals in with one of the works written by William Faulkner, a great American writer. He often writes the common problems in the world in his writing, especially about tradition, moral confusion and the fate of the black man.
