#### CHAPTER I

#### INTRODUCTION

## A. Background of the Study

Freedom of choice is expected by every people. Since they live their own life, it is entirely their right to choose what they are going to do or what they are going to decide for the sake of themselves. But there is also a fact that not all human beings can do this. There are several considerations they have to think of before making decisions. Radchyffe Hall was known as one of the remarkable English writers. She began her career by writing verses, which were collected into four volumes of poetry, *The Blind Ploughman*. Even one of her best poems was set to music by Conigsby Clarke. She published her first two novels, *The Forge* and *The Unlit Lamp* in 1924. Two years later she published *Adam's Breed* which made her won Prix Femina and James Tait Memorial Prize for fiction in 1927. Her best-known book was *The Well of Loneliness* which was published in 1928. It created a scandal and was banned for a time in Britain for its treatment of lesbianism. *The Unlit Lamp* was written before *The Forge*. It is often compared to *The Well of Loneliness*, but it is much better written. Both suffer in their accounts of women's love for each other. (1981:1)

The Unlit Lamp is a story about Joan Ogden, who grows up, and grows old in a little town on the South Coast of England. Her mother, Mary Ogden, whom she loves very deeply, and an affectionate governess, Elizabeth, with whom she shares her future dreams, are the two people who have great influence on her. Both want to have her companion, and they are not prepared to share her. Their struggle to posses her affects and shapes her entire life.

Viewing the title, The Unlit Lamp, the writer has certain curiosity. The word unlit here, possibly means the situation of not being turned on, and lamp, is a word means the source of light. The title plays a big role, for it might expresses the content or the extract of the novel. Compared to the story, the lamp probably represents Joan Ogden herself, or something more abstract like future for instance. It does not block the possibility that the lamp might represents someone or something else. Joan gets the spotlight mainly because she is the main character. With the potentials that she has, she should have been a more useful person for others, considered from her wish to be a doctor. If it is true that Joan Ogden is really meant the lamp, there is another question about the reason of the lamp to stay unlit, for it is supposed to give the light. Furthermore, it would also be interesting to find out whether there has been someone who tried to light this lamp up or not, and also why this attempt goes fruitless. By looking at the flow of the story, it will later can be found whether this presumption is reasonable or not. Further observation deals with the novel will lead to the conclusion if the title really means something as the writer has assumed before.

The Unlit Lamp is a very interesting novel to discuss. The main character here, Joan Ogden, is a complicated person. She is not an ordinary person, a typical little girl

who lives in a small town, who mostly does not have expectation to gain something incredible in her life. She has the potential to be successful. She has the great talent and intellectual ability to follow her dreams. Her governess, Elizabeth, is the right person to light her fire, to help her to be what she really wants, and her mother, is a demanding person who does not want to share her with anyone else. Later, Joan finds the fact that both her younger sister and her father dies too soon. She is the only one left with her mother. Her conflicts begin when she has to choose between accompanying her lonely mother, and moving away with Elizabeth to continue her study. She also has to make an important decision about getting married to the man who really loves her.

Joan Ogden. The writer intends to find out the family background which influences
the main character. Her relationship with the other family members, with other people
around her, will lead to the understanding about the main character herself.

The extrinsic elements that the writer will use are psychological and sociological approach. The process of her making decisions can be seen by psychological approach.
