CHAPTER I

INTRODUCTION

Since its development, Tanjung Perak harbor has given a considerable contribution to the development of economic and has had important role not only to increase trade traffic in eastern Java but also to increase trade traffic throughout the eastern region of Indonesia. The development container done by Tanjung Perak port is directed at the dock expansion, particularly container dock, improvement of facilities, development of port industrial area, and development of a passenger terminal. The increase of economic activities and business in the port area of Tanjung Perak, finally encourages government to establish PT Pelabuhan Indonesia III, which is a State Owned Enterprises (SOEs). PT Pelindo III Tanjung Perak becomes one of the centers of port in East Java. PT Pelindo III Tanjung Perak is enganged in the transport sector such as giving the task, authority, and responsibility for managing the harbor. PT Pelindo III Tanjung Perak is believed to be the provider of port services facility, which has a key role to ensure continuity and smoothness of sea transport, such as provision of passenger terminal, a schedule of departure and

delay of a ship, the dock as a tie up and unloading of goods, so that the availability of sea transportation is able to developing economic activities in the state and society.

As a big company, PT Pelindo III Tanjung Perak has become imperative to keep the good image of the company and the balance between work environment with the local community and the partner company.
