ISI : Penelitian ini bertujuan untuk menganalisis pengaruh pendapatan asli daerah, dana alokasi umum, dana bagi hasil, dana alokasi khusus, dan dana otonomi khusus terhadap belanja modal dan pertumbuhan ekonomi kabupaten/kota di Provinsi Papua tahun 2008-2014. Penelitian ini menggunakan persamaan simultan yang dianalisis dengan metode dua tahap kuadrat terkecil (2SLS). Hasil penelitian ini menunjukkan bahwa secara bersama-sama variabel pendapatan asli daerah, dana alokasi umum, dana bagi hasil, dana alokasi khusus, dan dana otonomi khusus berpengaruh dan signifikan terhadap belanja modal. Secara parsial, dana alokasi umum, dana bagi hasil, dan dana alokasi khusus berpengaruh signifikan terhadap belanja modal, sedangkan pendapatan asli daerah dan dana otonomi khusus tidak berpengaruh signifikan terhadap belanja modal dan belanja modal berpengaruh signifikan terhadap pertumbuhan ekonomi kabupaten/kota di Provinsi Papua periode tahun 2008-2014.

THE EFFECT OF REGIONAL OWNED-SOURCE OF REVENUE, BALANCING FUNDS, AND SPECIAL LOCAL AUTONOMY AGAINST CAPITAL SPENDING AND ECONOMIC GROWTH REGENCY/MUNICIPALITIES OF PAPUA PROVINCE ON YEAR 2008-2014

CONTENTS : The purpose of this study is to analyze the effect of Regional Owned-Source of Revenue, General Allocation Fund, Tax-and Non-Tax Based on Revenue Sharing Funds, Specific Allocation Fund and Special Local Autonomy to the Capital Spending and Economic Growth regency/municipalities of Papua Province on year 2008 until 2014. This study uses simultaneous equation and then analyzed by 2SLS method. The result of this study showed that the Regional Owned-Source of Revenue, General Allocation Fund, Tax-and Non-Tax Based on Revenue Sharing Funds, Specific Allocation Fund and Special Local Autonomy variable had effect on the capital expenditure significantly. Partially, General Allocation Fund, Tax-and Non-Tax Based on Revenue Sharing Funds, Specific Allocation Fund had effect on capital expenditure significantly, while the Regional Owned-Source of Revenue and Special Local Autonomy had no effect on the capital expenditure significantly and had effect to the economic growth on the district/city of the Province of Papua in 2008-2014.
