Konvensi Internasional dan Putusan Pengadilan Internasional :

Convention on the Elimination of all Forms of Discrimination Against Women (CEDAW), Adopted and opened for signature, ratification and accession by General Assembly resolution 34/180 of 18 December 1979 entry into force 3 September 1981.

Draft Articles on The Responsibility of International Organizations (DARIO) 2011, Adopted by International Law Commission at its sixty-third, in 2011, and submitted to the General Assembly as a part of the Commission’s report covering the work of that session.

Universal Declaration of Human Right, the Declaration was proclaimed by the United Nations General Assembly in Paris on 10 December 1948

Rome Statute of the International Criminal Court, adopted by the United Nations Diplomatic Conference of Plenipotentiaries on the Establishment of an International Criminal Court on 17 July 1998.

Charter of The United Nations and Statute of International Court of Justice, entry into force October 24, 1945, proclaimed by the President of the United Nations States October 31, 1945.

International Covenant on Civil and Political Rights (ICCPR) 1976, Adopted and opened for signature, ratification and accession by General Assembly resolution 2200A (XXI) of 16 December 1966, entry into force 23 March 1976.
