Reference to your e-mail regarding publication of your article entitled: ““Development and validation of hplc method for determination of morachalcone a in rabbit plasma (in vitro)” (authors: Michael Raharja Gani, Isnaeni, Amirudin Prawita, Achamad Fuad Hafid And Aty Widyawaruyanti). This is to inform you that your paper has been examined by the referee, and recommended for publication after revision as Report, comments of referee are as under:

Comments

There are many typographical, grammatical errors and merging of words made by author extensively in the manuscript (like “% different” need to be corrected as “%difference” and etc.).

Numeric values must be corrected in manuscript as these errors not consider as typos (like 2,79% need to be corrected as 2.79% and etc.). Each numeric value required its unit.

PJPS Author guide needs to be considered regarding formatting in manuscript particularly to correct reference formatting either they are cited in the text or listed separately under the title ‘References’.

The title can be revised as “Bioanalytical method development and validation for quantification of Morachalcone A in rabbit plasma using HPLC”.

According to the title the key words and introduction can be revised.

Revised redundant phrases, paraphrasing and comprehensive set of wordiness used in constancy in manuscript. Introduction 1):” In previous studies, *Artocarpus champeden* (*A. champeden*)..... activity against *Plasmodium falciparum* 3D7 strain². 2) Last paragraph: “In order to develop antimalarial phytomedicine product determine morachalcone A in rabbit plasma.” Can be revised by using these type of sentences:” method development and validation plays a significant role in evaluation and interpretation of bioavailability, bioequivalence, pharmacokinetic, and toxicokinetic studies.

Abstract 1-) (e.g.” 1st sentence “*Artocarpus champeden* ethanol extract.....,with morachalcone A as it’s active marker compound” need to be corrected as “the active marker compound was **identical** with known prenylated chalcone compound, Morachalcone A”.

Similarly the abstract should be revised completely to eliminate the wordiness phrases with the incorporation of methodology guidelines that has been followed.

In all the validation parameters need to mentioned the acceptance criteria with respect to the reference or adopting guidelines and report the data or graph for each parameter.

Calibration solution 1-) need to correct the sentence: "After that, into the calibrations plasma wasrabbit plasma and shortly vortexed". 2-) calibration curves need to show with corresponding data.

It is good if you perform the system suitability report in the manuscript.

Precision and accuracy 1-) mentioned the time gap in intra-day investigations. 2-)" Intra-day precision and accuracy were analyzed by analyzing samples replicates analysis (n=5) at low, medium and high QC samples on one day" need to be corrected as "Intra-day precision and accuracy were performed by analyzing samples (n=5) in replicates at three concentrations(464.516 ng/ml, 1470.968 ng/ml and 2477.419 ng/ml).

Extraction recovery: mentioned the analyzed concentrations with respective recovery data. "Recovery pertains to the extraction efficiency of an analytical method within the limits of variability".

RESULTS→ Selectivity): this sentence need to be corrected "The selectivity was determined by analyzeblank rabbit plasma sample and blank rabbit plasma that was spiked with both morachalcone A and internal standard (4-hydroxychalcone)".

Report the retention time period of analytes.

Discussion: Use the suitable description of validation parameters considering the results and correlate with relevant studies. Discussion should be comprehensive and re-phrase the paraphrasing like "Acetonitrile-water (50:50, v/v) and flow rate 1.0 mL/min were selected as mobile phase with isocraticeluation because it is simple, easy to use and produces parameter which fulfilled the chromatography acceptance criteria".

You are required to revise above paper as per above comments of the referee and send us alongwith RESPONSE SHEET (attached) showing queries and their responses, also revise version of manuscript with highlighted revised portions as soon as possible for further process.
