



### General comment:

The manuscript should be rewritten to be more concise and precise and proofread by English expert (several points mistake)

### Abstract

Section of Abstract needs rewriting in a concise way.

1. What did you mean? “Parasite DNA of 20 of positive samples were extracted and were amplified by PCR and were the sequence to identify the subtype of Blastocystis sp.” in line 9-10, please explain clearly
2. What did you mean? “Morphologically, all of the samples from both fresh stool and culture were 100% positive with Blastocystis sp.” in line 11-12, please rewrite clearly
3. Why you did not present the prevalence of Blastocystis sp. in the percentage
4. I did not observe the keyword “zoonotic” in your abstract

### Introduction

There is an obvious language flaw and redundancy. Moreover, this section needs to rewrite.

1. Please add the studies (references) that identity the Blastocystis in animals in your country and the others.
2. In line 34-36, needs rewriting because fecal-oral transmission is usually waterborne and/or foodborne
3. In line 37-38, please check the data again. Is it true?
4. In the last paragraph in the introduction, please describe the benefit of these reports.

## Materials and Methods

1. In Method part, indicate the age range of the cattle and how many farms that you collect the stool sample from cattle?
2. Location of farms is nearby the community or not, please explain
3. Microscopic examination, did you perform both 0.85% normal saline and iodine solution? Please explain clearly
4. How did you check the positive samples from the culture? You did not mention.
5. You did single round PCR for detecting Blastocystis. However, it is a very short sequence to reconstruct the phylogenetic tree and compare it to reference sequences in Genbank. Why you select these primers? Please explain clearly
6. In line 91-99, please rewrite clearly
7. Please add Statistical analysis, I think you used “Descriptive analysis (percentages)”, as well. So, you should add the sentence.
8. Please indicate the reference sequences that you use in this study

## Results

1. I am very confused about your explanation. From the microscopic examination, the result shows that the prevalence of Blastocystis was 100 % but PCR showed only 20 samples. Is it possible? Because PCR method (sensitivity and specificity) should better than microscopic examination
2. Please indicate accession numbers from Blastocystis positive samples in this study in Table 2 and the age of cattle
3. The short sequence from your study can indicate subtype? Why you did not use barcode region (600bp) or 1100 bp pcr product because it is more reliable than short sequence.
4. Please reconstruct the phylogenetic tree. What is the outgroup in this tree?

## Discussion

There is obvious language flaw and redundancy (introduction part). Moreover, this section needs to rewrite.

1. This part needs rewriting in the manner of comparison of your results with those from relevant animal species in Indonesia and neighboring countries in detail.
2. Please discuss, why the PCR is lower sensitivity than wet smear and culture in your study
3. Please discuss the different points of the primers that you used in this study with the other primers such as barcode region and the others
4. Please discuss the age of infected cattle and the infected cattle are in same cage or not?

## Conclusion

Section of conclusion needs rewriting in concise way.




